Early Childhood Development

4K • Child Care • Early Head Start • Head Start



The Department of Education reports that multiple studies show children from all income and racial groups benefit from quality preschool, but the impacts are particularly powerful among children from low-income families. Without preschool intervention, these children will, on average, start Kindergarten 12-14 months behind their peers in reading and language. The benefits gained from quality preschool can carry over into adulthood and have long-term benefits on a child's future success in the community.

CAP's Head Start, Early Head Start, 4-year old Kindergarten and Children's Discovery Center are designed to provide this preschool intervention.



Housing Development

Weatherization • Rental Properties • Home Buyers and Rehabilitation Assistance

Affordable housing is defined as paying no more than 30% of one's income on housing related expenses. Low-income families often pay a disproportionate share of their income on housing, negatively impacting their ability to meet other basic needs. Additionally, children who grow up in poorquality housing experience greater emotional and behavioral problems at young ages and later see their school performance suffer, according to one of the most comprehensive assessments conducted on the impact of housing on children in the U.S. (2007 Three City Study). CAP's Homebuyer, Housing Rehab and Weatherization Assistance Programs are all designed to improve both the quality and cost of housing.

CAP Services held a meet and greet for the new Waupaca Eco Park in August 2014. The park will create permanent environmental education opportunities while maintaining the natural feel of the area. CAP's Fresh Start Program crews will build most of the park's components.

Decades ago, President John F. Kennedy reflected on how the immigration process contributed to the evolution of our great nation and became "central to the whole American faith." Immigration, he added, "gave every old American a standard by which to judge how far he had come and every new American a realization of how far he might go."

The Hmong first started arriving in the US in the late 1980s as a result of persecution for having helped the United States during the Vietnam War. CAP began offering comprehensive family development and interpretation services to help these families build a new life in a land strange to them. Hundreds of community education programs helped deepen an understanding of both American and Hmong culture.

Since 1989 when CAP began its partnership with the Hmong community in Portage County, we've seen significant progress. Of the approximate 250 Hmong households in the county now, 125 (50%) are homeowners and 113 live in private rentals. Nearly 700 individuals are employed. The gains made are remarkable.

Similarly, CAP's Human Development Department offers comprehensive family development services in a number of programs that include the Family Crisis Center, Skills Enhancement Program, Family Resource Center, Work N Wheels, free tax assistance services, Fresh Start and more – all designed to help families build a stronger future.

"Without CAP Services' Skills Enhancement Program, life would be a much bigger struggle. It is helping people like me achieve their dreams. My dream is to have a career as a Certified Occupational Therapy Assistant helping others, to be an asset to our community, and one day when my son is ready, to have the means to help him also get a college education."


CAP Operations and Financials





CAP Services experienced a 5% growth in program services in 2014. Finance and Administration managed \$17.2 million in operating funds with assets of \$50.7 million. Staff is credited with clean financial audits and efficient human resource and information technology functions.

CAP's workforce of 225 earned a payroll of \$6.2 million in 2014. Assuming a conservative multiplier of 1.5, the economic impact of payroll alone totaled just over \$9 million for central and east central Wisconsin.

CAP strives to be an employer of choice for mission-oriented individuals. Much of our success lies in hiring staff who identify with CAP's mission and who want to be identified as being part of our organization.
